#### Information about Personal Data Processing

Through this document we, as the personal data controller – Škoda Auto a. s., registered office: tř. Václava Klementa 869, Mladá Boleslav II, post code: 293 01, Reg. No.: 00177041, registered in the Commercial Register kept by the Municipal Court in Prague under file ref. B 332, (hereinafter referred to as "Škoda Auto") – provide you with information about personal data processing and your rights related to the processing.

The processing occurs as part of the following activities.

## Purpose of processing:

Škoda Auto product and brand promotion.

#### Description of the purpose of processing:

Škoda Auto organizes marketing events during which photographs and videos are produced by the organizers. These photographs and videos, in which you can appear as a participant of the event, can subsequently be used in Škoda Auto promotional materials.

#### **Authorization to process:**

Personal data processing is based on the given consent.

### Categories of personal data that we process:

Photographs / video

## Processing period and archiving:

For unlimited period of time – unless your consent is withdrawn.

### Categories of processors or recipients to whom we may disclose personal data:

Media, photographers, social networks, Importers, cooperating agencies. Upon request, your personal data can be provided to public authorities, in particular to courts, police, and other law enforcement agencies to the necessary extent and within the law.

## Source of personal data:

We receive the personal data directly from you.

## Transfer of personal data to third countries or multinational companies:

As part of this processing your personal data may be transferred to other Škoda Auto group companies or potentially also other recipients in third countries, i.e. in the People's Republic of China and Republic of India. This transfer will take place in such a case based on standard contractual clauses, i.e. a sample contract issued by the European Commission without a change in its text as anticipated by current legal regulations concerning personal data protection. ### Automated decision-making on the basis of personal data:

The right to access your personal data that are being processed.



The right to restrict or block the personal data processing.

The right to withdraw your consent to the processing of your personal data.



The right to receive your personal data in a structured and machine-readable format for yourself or for another controller.

The right to correction of inaccurate or incorrect data or to addition of missing data.



The right to object to the processing of your personal data if you believe that the processing is not legitimate.

The right to have your personal data erased if they are no longer necessary for the purposes for which they were collected or in the event of unauthorized processing.



The right not to be the subject of automated decision-making
